# CAMPER AGREEMENT FOR 2020 CAMP HOLLYMONT FOR GIRLS

(Including Release of Liability and Indemnity Agreement)

Please read this Agreement carefully. This is a contract and your signature below indicates that you have read and understand every provision of this Agreement and that you unequivocally agree to all terms, conditions and promises herein. By signing below, I, the undersigned parent (or guardian) of my Camper, on my own behalf and on behalf of my Camper, as consideration for Hollymont, Inc. dba Camp Hollymont for Girls (hereinafter "Camp" or "Camp Hollymont") allowing my Camper to attend Camp Hollymont, agree and promise as follows:

RISK OF INJURY AND ASSUMPTION OF RISKS: I acknowledge that I am fully aware of all aspects of Camp Hollymont's programs, activities, premises, and risks. I have been given ample opportunity to ask any questions which I may have about the activities and the environment to which my Camper may be exposed, and I understand that there are risks of injuries and possibly death from some of the activities at Camp Hollymont.

I am aware of the dangers and risks which are inherent in the operation of an overnight children's camp and in my Camper's participation in all Camp activities on or off the premises of the Camp. The following describes some, but not all of these risks:

1. **Environmental Hazards:** I understand, accept, and assume the inherent risks associated with recreating outside, including but not limited to, potential exposure to changing weather conditions, lightning, insects, spiders, snakes, animals, sunburn, hypothermia, dehydration, poison ivy/oak, ticks, and mosquito bites.
2. **Recreational and Outdoor Activity Hazards:** I understand, accept, and assume the inherent risks associated with the activities at Camp Hollymont, including, but not limited to, those risks that can arise from swimming, boating, hiking, or athletics, including bodily contact, gymnastics, cheerleading, dance, use of tools and equipment in cooking, arts and crafts, sewing, work projects and other programs, tubing, caving, rafting, creek hiking, biking, archery, ziplining, water-skiing, ropes course, canoeing, kayaking, fishing, horse-back riding, camping out, outdoor-living skills, and vehicular travel.
3. **Medical Care:** I understand, accept, and assume the inherent risks associated with the fact that some of Camp Hollymont's programs and activities occur in more remote locations, where cell phone service may be unavailable and prompt emergency medical care and transportation may be significantly delayed.
4. **Travel Risks:** I understand, accept, and assume the inherent risks that are associated with my Camper traveling by van, car, bus, bike, and by any other means, including in locations where there may be dirt roads and trails over unpredictable terrain.
5. **Human Risks:** I understand, accept, and assume the risks that could arise from the acts, conduct, and mental/emotional state of my Camper and her fellow participants that are outside the control of Camp Hollymont. These risks may include, but not be limited to, episodes of panic or similar emotional episodes, negligent acts by my Camper or other campers, and failure to follow direction or instruction.

I further understand, accept, and agree to assume that these risks involve risks and dangers ranging from minor injuries, such as scrapes and bruises, to serious or catastrophic bodily injury, including permanent disability, emotional and physical trauma, paralysis, and the possibility of death.

# CAMPER AGREEMENT FOR 2020 CAMP HOLLYMONT FOR GIRLS

(Including Release of Liability and Indemnity Agreement)

RELEASE OF ALL CLAIMS: I, the undersigned Parent/Guardian, individually and on behalf of my Camper, do hereby release Hollymont, Inc. dba Camp Hollymont for Girls, Asheville School, and, as applicable, their respective officers, directors, members, managers, shareholders, administrators, agents, employees, staff, volunteers, successors, and heirs (collectively "releasees"), from any and all liability, claims, demands, losses, suits, or damages arising from, in whole or in part, my Camper's participation at Camp Hollymont, including any and all claims for personal injury, wrongful death, emotional distress, and/or claims arising from rescue, emergency response operations, and/or any medical care provided to my camper while attending Camp Hollymont.

PARENTAL INDEMNIFICATION: I further agree and promise to indemnify, defend, and hold harmless each and all of the releasees from any and all claims, suits, and/or any other legal dispute that are brought by or on behalf of my Camper for any claims arising out of my camper's enrollment or participation with Camp Hollymont, whether or not such claim arises out of the alleged negligence or other conduct by any of the releasees.

RIGHT TO REFUSE AND EXPEL: I understand and agree that Camp Hollymont reserves and retains the right, at its sole discretion, to cancel, reject, and/or refuse the application, admission, and/or participation of my Camper from the Camp and/or any of its programs and that the Camp can exercise this right at any time, including expelling my Camper while attending and/or participating in the Camp's programs. I further understand that in the event the Camp exercises this right, it may, at its sole discretion, retain or refund any and all deposits, fees, tuition, or other moneys paid for my Camper to attend Camp Hollymont.

PAYMENT AND REFUND POLICY: A deposit paid with the application is required to reserve a spot for my Camper. I understand that the deposit is refundable until May 1, 2020, except for a \$150 per camper processing fee. The remaining balance is due May 1, 2020. Any past due account after May 15, 2020, will result in cancellation of my Camper's enrollment with no refund of the deposit.

CLUSTER PLACEMENT POLICY: I understand and agree that Camp Hollymont reserves the right to place each camper in the cluster the Camp feels is best. Girls within the cluster are approximately the same age and grade. Cluster preferences are initially shared via the camp application and may be changed or added later by logging into Bunk1 and completing the form "Notes for Your Camper's Counselor". All requests must be made prior to May 1<sup>st</sup>. Hollymont works to accommodate a maximum of two requests. No more than three girls from the same hometown can be in one cluster. Campers must be staying the same length of time and parents must agree on the request. Cluster requests are for girls to be in the same cluster, not the same room. While careful consideration is given to each request, the final decision rests with the Camp. I agree to support Hollymont's final decision regarding my Camper's cluster assignment.

AUTHORIZATION FOR USE OF PHOTOGRAPHS/VIDEO: I understand and agree that my Camper may be photographed and/or video recorded while participating at Camp Hollymont. I hereby authorize the Camp to use any photographs, videotapes, motion picture recordings, or any other record of my Camper for publicity, advertising, or for any other legitimate promotional purpose. I also grant permission for the Camp to use my comments and testimonials in promotional materials.

CHOICE OF LAW/SUBMISSION TO JURISDICTION AND FORUM: I agree that any legal dispute between Camp Hollymont or any of the releasees arising out of or related to this agreement or my Camper's enrollment and/or participation with Camp Hollymont shall be governed by the substantive laws of the State of Georgia. By signing below, I understand I am agreeing to submit myself and my Camper to the personal jurisdiction of the State Superior Court located in Rabun County, Georgia, and any action, lawsuit, or other proceeding against Camp Hollymont or the releasees shall only be brought in the State Superior Court located in Rabun County, Georgia.

INTEGRATION: I understand and agree that this Agreement is a fully integrated contract and supersedes any oral and/or written expressions by Camp Hollymont whether given directly or indirectly to me.

SEVERABILITY: In the event that any clause or part of this Agreement is determined or found to be invalid by any court of competent jurisdiction, this finding shall not otherwise affect the validity or enforceability of the remaining parts of this Agreement.

## AUTHORIZATION

I, the undersigned Parent/Guardian, state affirmatively that I have legal custody of my Camper, a minor child, and I have complete authority to sign this Agreement on my Camper's behalf. ## SESSION OPTIONS

Hollymont's traditional session lengths are 13 and 27 days.

Each 13-day session is built upon a framework of the opening day activities, council ring, talent show, Sunday chapel, a tea party, waterfront activities at Camp Rockmont, skill show, special Thursday closing activities, and the final Friday morning watch. Other activities rotate throughout the summer to create unique 13 and 27 day sessions.

The 6-day Starter session is designed for first-time campers who are not quite ready to commit to a 13-day session.

## POLICIES

Hollymont is a place filled with friends, fun and loving encouragement. Campers are expected to treat others with kindness and respect, and to uphold the Hollymont ideals and policies. The camp directors reserve the right to refuse admission to any camper or to dismiss any girl who, in their opinion, is deemed disruptive, disobedient and/or an undesirable companion for other girls. **NO REFUND MADE**

*Possession of or use of tobacco products, alcoholic beverages, illegal drugs, improperly obtained prescription medications, knives/firearms/explosives are prohibited. Use of profanity, deliberate abuse of self or abuse of others (bullying, sexual harassment, and/or inappropriate touch) or their property, or leaving the Hollymont premises without the directors' permission are strictly forbidden.*

We request that campers leave animals, cell phones, digital cameras, iPods, iPad, laptop computers, DVD players, and other electronic equipment at home. IF campers choose to bring their personal sporting equipment to camp, some items may be left in their rooms (softball gloves and tennis racquets) while other items (archery bows, softball bats, etc.) will be stored and locked in the skill shed. We ask that all items be well marked with the camper's name. **WE ARE NOT RESPONSIBLE FOR ANY LOST OR STOLEN ITEMS.** Campers and CITs may not bring personal vehicles to camp.

## FEES

A deposit and fees for optional activities must accompany the application.

Session fees are listed above and trip/skill fees may be found on the application. Payments made are refundable until May 1, 2020, except for a \$150 processing charge. Please make checks payable to: Camp Hollymont for Girls. The remaining balance is due on or before May 1st.

There is no reduction in fee for those arriving late or leaving early except for a withdrawal due to illness or accident. In such a case, a credit for the balance of time will be applied toward the next year.

A charge will be made for early arrivals/late departures.

## PRE-CAMP COMMUNICATIONS

Once the application and deposit is received and accepted, we will send a confirmation.

Periodically during the year, we will send e-mails to parents that provide information for the upcoming summer camp season. Campers will receive newsletters in the mail throughout the off season months.

In April, in-depth information relating to the camper and her specific session will be available online via the Bunk1 website. We will also be sending information to parents via e-mails and occasionally by mail.

## SPIRITUAL EMPHASIS

Hollymont's top priority is to foster each camper's physical, social, and spiritual development in the context of an independent living, loving Christian environment. We carefully select women for our staff who challenge and inspire as much by their example as by their words.

Hollymont days begin with Morning Watch. Immediately after breakfast, we all gather in the chapel for enthusiastic singing and cluster-led devotions to give each camper and staff member a spiritual "jump-start". In the evening prior to "lights out", counselors gather their campers for cluster devotions. We seek to give each camper positive direction for all walks of life, and our hope is for each girl to experience the joys of a Christ-centered life.

## EVENING ACTIVITIES

In the evening, we offer a wide variety of hall, tribe, and/or camp-wide activities. These are designed to encourage team work, spirit and good sportsmanship, to gain self-confidence, to enrich the camp community at large, and to foster enjoyment of the great outdoors.

## TRANSPORTATION

The closest airport is the Asheville Regional Airport (approx. 20 minutes away). We will also pick up from and deliver to the Greenville-Spartanburg Airport in Greenville, SC (approx. 1.5 hours away)

If you anticipate flying your daughter to/from camp, it is essential that you make reservations early! **We strongly recommend that you schedule air arrivals and departures before noon.** Given the combination of summer weather and heavy air traffic, it is not uncommon for afternoon flights to be delayed or cancelled.

Although most airlines offer an unaccompanied minor program, airline policies can change without notice. Please inquire with the individual airlines about their unaccompanied minor program when you purchase your ticket and again the week before daughter's scheduled flight. Ask specifically about escorts for connecting flights. If we are given sufficient advance notice, campers will be greeted by camp personnel at the Asheville Regional Airport or Greenville-Spartanburg Airport.

## INSURANCE

Please note that we do not carry health or accident insurance on campers. Campers must be covered under a policy provided from home. Medical bills incurred while at camp will be forwarded home for submission to your health insurance company.

## SKILLS/ACTIVITIES

Campers attend 6 skills daily, except when pre-empted for trips or special activities. **There are a few skills for which campers must pre-register and pay a fee because the number is limited and special equipment and/or staff are required.** These skills include **cooking. More paid skills will be offered and announced in March. Please refer to our website at that time to add additional paid skills if desired.**

In March, we will make our skill selection sheet available on Bunk1. Please complete and return the form in the spring. **Signing up for paid skills on the skill sheet does not guarantee a spot in those skills.**

Skill offerings for a given session are determined by the camper skill requests and the availability of teaching staff.

We begin placing campers in skills prior to their arrival but we will not have their final skill schedules until late Sunday night of opening day. Schedules are distributed on Monday morning prior to 1st skill.

## WHAT TO BRING

Camp activities are best enjoyed in play clothes. (Shorts, t-shirts, Tennis shoes, etc.) Sundays provide an opportunity for campers to dress up a bit (sundresses or nice outfit). **In April, a packing list will be provided online.**

## CAMPER SPENDING

Campers do not use cash at camp. Charges from the camp store, canteen, personal item requests, medical expenses and small group activities are recorded on each camper's spending sheet. Recommended spending account is \$75 for 6 day campers and \$100 for 13 day campers. You may give us a spending limit and we will "run a tab" charging the final amount actually spent to the credit card you leave on file with our office or you may leave cash with the business office on opening day. We will monitor and discuss your camper's spending with her and contact you if your camper is at or near her spending limit.
